## **USCG Inspection of Constant II (George and Polly's boat).**

This story from George Cajigal, our Treasurer.

At the suggestion of Rear Commodore Shannon Ritter, who very kindly drove to Charleston to pick up Polly, Andy Normand (our friend and crew), and I at the end of our 1<sup>st</sup> leg of our cruise south, I am sharing my experience on being boarded by the USCG for an inspection in Charleston Harbor on Friday, November 22. I hope that by sharing this experience, it will better prepare our members for a similar event, or remind those that have not had a recent inspection of what to expect.

This is my second boarding for inspection by the Coast Guard. The first one was probably 20 years ago at the New River Inlet in NC by Camp Lejeune. The channel markers in the area are most confusing as we have the confluence of the ICW, the Inlet, and the New River channel markers. My brother and I were doing circles trying to figure them out and I guess the USCG patrol thought we were somehow impaired – figure that. Luckily, we were just confused. I don't know which is worse. This was before the chart plotter age.

I have no idea why we were hailed down in Charleston Harbor other than it was rather a balmy Friday afternoon; a nice time to be boating. Or maybe it was the fact that I had left my running lights on as we had left Georgetown, SC, in foggy, limited visibility weather and forgot to turn them off later in the day.

The boarding party hailed us and asked us to slow down. Polly took over the helm while I, with Andy's help, tended to the inspection. Before boarding they first asked us if we had any weapons on board to which I replied, we did not. Once that was clear, they pulled their boat alongside and boarded while we were slowly motoring. Two officers came on-board. I think one of them was undergoing on-the-job training. Two others remained in their boat. They had an M-60-looking machine gun on the bow. I could not see whether the ammo belt had been fed or not. I wondered what would have been its status if I had told them I had a weapon in our boat.

We started the inspection sitting down on one of the dock boxes on the bow. After introducing themselves, I was asked for my driver's license and them proceeding to filling out the Boarding Report.I am not going to bore you with every detail, but focus on what impressed me. They first asked for the vessel documentation, checked that we had a life vest for each individual on board, that we had a horn (my mounted horn was weak but I had a can horn that sufficed) and a bell (required for vessels 50' and larger). I had to show them the fire extinguishers, where the vessel's document number was permanently fixed to the boat, the location of the pollution placard (mine is in the engine room) and the garbage placard (mine is located besides the stove). In the engine room they really looked worried about oil in the bilge but I showed them that I had oil absorbent pads in the bilge as well as I was using "Bilgeclean" and that met their satisfaction. It would have been better to have a completely clean bilge in the engine room and to do that is high on my "To Do" list now. They asked me to show them my sanitation devices to make sure I

was not discharging sanitary waste directly overboard. As I had just installed PureSans in the boat, they were satisfied that this was not a problem. What surprised me the most is that they required a written "Waste Management Plan". I found out later that this is required for all vessels over 40'. I did not have one but wrote one on the spot and they were satisfied. They told me that I needed to keep it with my vessel documentation. I have put this short, and straight to the point, Waste Management Plan below, for you to use as you see fit.

The end result of the inspection was that they found "No Violations". Throughout their inspection, they conducted themselves in a very professional and courteous manner. I thanked them for their work and their service. They hailed their boat to come alongside Constant II and departed the same way as they came, without us having to stop or slow down. We continued on our way and noted a few minutes later that they had boarded another motor boat in the harbor. We wished them luck and proceeded to St. John's Yacht Harbor where we are keeping the boat until after the holidays, when we hope to continue south, as far south as we can before having to turn back north in the spring.

#### Constant II Waste Management Plan

No garbage or any kind of debris is to be dumped overboard into the water.

All waste is to be bagged or placed into a container for appropriate disposal on land.
